#### **PURPOSE**

The purpose of the Wakulla Middle School Band program is to offer students in the 6th, 7th, and 8th grades an opportunity to learn about instrumental music in a positive, fun environment. It is our desire to give each and every student the experience of creating music and expressing creativity through music. We believe that every child has the right to develop a lifelong love of music. Our band program exists to help facilitate that development and to prepare them to meet the high school entrance level as stated through the Sunshine State Standards and the local high school.

#### **EXPECTATIONS**

Band is a team undertaking and a *co-curricular activity*. As a co-curricular activity, students will participate during class time in addition to some after-school events that are *required*. Every member is valuable, and as such, every member is expected to be present and giving their best effort in class, at each event, and in their practice time at home. Students will learn all the musical concepts and instrumental techniques they need to in order to be successful on their instrument during class time but must solidify those techniques on their own time through individual practice outside of class. Parents/guardians are expected to ensure their student is practicing consistently.

Band events, including rehearsals, performances, concerts and some special functions will occur periodically throughout the year. The Director will give advance notice of each event such that each member is fully capable of attending and staying the entire time. If there is an issue, a parent/guardian must contact the Director in advance to receive an alternate assignment. Communication between student, band director, and family is absolutely vital for success of the ensemble. The director primarily communicates through email and handouts sent home with students. Please ensure you have an up-to-date, active email that you check on file so that you don't miss any communication.

#### CLASSES / AVAILABLE ENSEMBLES

BEGINNING BAND (BAND I): This course is designed for students who have never played a specific Band instrument before. No previous experience on any instrument or with music reading is necessary. Students in this class will learn everything from the beginning—music reading, music writing, music history, playing

an instrument, care of instruments, and making music together! Students will have at least three performances during the school year in the form of public concerts. Attendance at each is mandatory. In preparation for these performances, there will be a few after-school rehearsals on specified dates. Attendance for these will also be required.

CONCERT BAND (BAND II): This course is for students who took Band I the previous year or played an audition for and received approval from the Director. This ensemble will build on concepts and lessons from Beginning Band. Students will have more performance opportunities, including at least three required concerts, pep band performances at home football games, and the opportunity to participate in Solo & Ensemble, All-State Bands and Orchestras, and All-District Honor Band. This ensemble will rehearse weekly on a specified day of the week for an after-school rehearsal. Attendance at each school concert/rehearsal and football game is mandatory, but there will be a few optional events, as will be clearly communicated to families. Students in this ensemble may be required to participate in a Music Performance Assessment (MPA) depending on the structure of the different ensembles within the program.

SYMPHONIC BAND (BAND III): This course is for all students who have successfully played an instrument in Band I and Band II, or who have played an audition for and received approval from the Director. In this class, students will continue to build on concepts and lessons taught in the previous band class but will work on more difficult music in a more advanced setting. Students will have several performances, including at least three required concerts, Music Performance Assessment (MPA), pep band performances at home football games, and the opportunity to participate in Solo & Ensemble, All-State Bands and Orchestras, and All-District Honor Band. This ensemble will rehearse weekly on a specified day of the week for an after-school rehearsal. Attendance at each school concert/rehearsal and football games is mandatory, but there will be a few optional events, as will be clearly communicated to families.

JAZZ BAND: This is an ensemble that does not meet as a class during the day. Rather, we meet weekly for an after-school rehearsal. Students must be enrolled in symphonic band or concert band an receive approval from the director to participate in this ensemble.

### PERFORMANCES, REHEARSALS & EVENTS

Notice of performances and rehearsals will be give well in advance by the Director. Student attendance and participation at each event and rehearsal for their respective ensemble is **mandatory and will contribute to the overall class grade of the student.** If there is a valid conflict, the Director must be notified immediately and *in advance* by the parent/guardian of the student. Students who must miss an event for a valid reason will be given an alternate assignment to make up the grade for the event/rehearsal that will be missed.

If a student misses a performance and a parent/guardian does not contact the Director, or the reason for absence does not qualify as an "excused" absence, the student will be given a grade of zero for that event. Habitual unexcused absences will significantly impact a student's grade, and a conversation between the Director and the family will occur regarding the student's continued membership in the Band. Students are expected to be on time and stay for the entire event unless prior approval is given by the Director. "Excused absences" include student or immediate family member documented illness, such that the student is unable to perform, or death in the immediate family. "Unexcused absences" are essentially anything else—for example (not an exhaustive list): lack of transportation, need to babysit, punishment, or student not communicating with family. Notice of performances and rehearsals will be given far enough in advance that these arrangements can be taken care of.

#### **CONFLICTS**

It is the desire of the band program that students should be able to participate in a variety of school activities (like band, chorus, sports, drama, etc). When teachers, students, and families work together and communicate, the majority of potential conflicts can be addressed before there are any issues. However, the following guidelines should be considered in the event of conflicts:

- 1) a *concert/performance* or *game* should take precedence over rehearsals or practices
- 2) a conflict should be reported to the Band Director by the student AS SOON AS POSSIBLE in order that potential solutions can be evaluated
- 3) Wakulla Middle School events will always take precedence over non-school related activities.

Conflicts will be handled on an individual basis. **Advanced notice is required**. There is usually a solution available and with enough time, the director is willing to explore solutions in order that a student can still actively participate in as many activities that a parent/guardian is willing to permit.

#### **DAILY PROCEDURES**

All procedures will be discussed with students in class so that everyone is aware of them.

Each Day, students will:

- 1. Come into the room quietly and quickly, get their instruments, supplies, and stands,
- 2. Sit in their assigned seat and assemble their instrument. \*
- 3. Students can *quietly* play/practice *their* instruments in their seat until the Director begins class activities. At that point, all noise will cease.
- 4. Classroom activities will be conducted by the director.

5. At the end of class, students will be given extra time to put up their instruments in an orderly manner and return to their seats. Students will remain in their seats once all materials are put away. The Director will dismiss each class once all necessary materials have been appropriately put away.

\*The director will provide students four minutes from the time the bell rings to complete steps 1 and 2. Any student who has not completed these steps in that amount of time may lose participation points at the discretion of the director.

#### **CONDUCT**

All students in the WMS band program are expected to follow the official Student Code of Conduct of Wakulla Middle School and the Wakulla County School Board at all times. The following conduct standards have been designed to create a positive learning environment. They are expected of all WMS band members at all times: Walk at all times.

- 1. There will be no talking or disruptive noises while the director is conducting activities.
- 2. There will be no food, drink (except water), candy, or gum allowed in the band room, or any time instruments are being played.
- 3. Students may not touch instruments or equipment that does not belong to them without permission from the owner AND the band director. This is a zero-tolerance violation.
- 4. Theft will not be tolerated and is a zero-tolerance violation.
- 5. Students must stay in their area at all times. There are certain areas in the band room/at performance venues students are not allowed to be.
- 6. Show respect to anyone and everyone in any class/event setting. This includes but is not limited to directors, instructors, classmates, guests, etc. No student may say anything negative, insulting, or demeaning to others.
- 7. Students will strive to maintain positive words and attitudes while participating in band activities and classes. No use of profanity or otherwise inappropriate speech will be permitted.
- 8. Use pencil, only, in class and when marking music.
- 9. No spraying of perfumes, body sprays, hairspray allowed in or around the band room.

## POSSIBLE CONSEQUENCES

Non-adherence to these conduct standards could result in one or more of the following disciplinary actions.

- 1. Verbal Warning
- 2. Removal from an activity
- 3. Lunch Detention
- 4. Parent/Guardian contact
- 5. Referral (Often paired with ISS, but not always)
- 6. Removal from the ensemble

If a student's actions warrant certain disciplinary actions, the director holds the right to enact any of the above disciplinary actions at any point, at their discretion.

#### **GRADING**

Student's grades in band will be determined according to the following criteria:

- a. Class/Rehearsal Participation: 30%
   (includes attendance at rehearsals, having ALL required materials, and exhibiting proper ensemble behaviors)
- b. Assignments: 30%
   (includes practice assignments and written assignments assigned to be completed in class or as homework)
- c. Tests/Quizzes/Performances: 40% (includes concerts, performances, events, playing tests in class, and recorded playing tests)

The grading scale is as follows:

A 100-90% B 89-80% C 79-70% D 69-60% F 59-0%

#### **EXTRA CREDIT**

There are a few ways that students can earn extra credit:

On a Scale Test, the student may choose to learn an extra octave. This can earn them one extra point on a test grade (for example, an 11/10), and tests are 40% of their grade. Even though it's only one point, it can significantly increase their grade. Attend a concert or performance! Any type of music at any place is acceptable! For example, you could attend your little sister's chorus concert at Medart Elementary, or a WHS Band concert, or listen to the guy who plays guitar at your grandma's nursing home, or an Imagine Dragons concert...basically, anything you can PROVE you were at. We highly recommend attending high school, collegiate, and professional band, and music performances. With our proximity to 2 major universities, a massive number of talented musicians perform in Tallahassee regularly and that is an opportunity that should not quickly be passed up! In order to get credit, students need to turn in a ticket or a copy of the concert program. If the director asks you some questions about it and you can't answer, you won't get credit—so don't lie, or it will be REALLY awkward and lying is not a characteristic of a well-rounded person, band member, or Wildcat.

#### **ELIGIBILITY & CONTRIBUTION**

As part of any ensemble in the WMS Band Program, students will be expected to maintain qualifying grades in all of their band classes. The minimum required band GPA to perform or travel to any field trip is a 2.0 (or a C average). Students will not be allowed to travel with the band in any capacity if they do not maintain this average across all calculated 9 weeks' grades. Band classes will be graded just as strictly and requires similar focus and long-range attention to detail as any academic course at the school. Students and parents must check FOCUS frequently and ask any questions that they may have upon seeing a low grade. Students can make up grades for most things in the grade book as long as it is within the 9-week grading period. Planning is crucial for success in this class.

Additionally, it is expected that all students involved in the band program will be "contributing members" of the ensemble. This is defined as "consistently contributing through instrumental performance and through personal investment in the band program." Students who do not add

to the experience of others both with their playing (e.g., playing their instrument each day in class) and their presence (i.e., students must not be rude or distracting so as to detract from another student's experience) may be asked to change ensembles or possibly be dismissed from the program. A parent conference/meeting will be scheduled before any such action is taken, and every opportunity will be given for students to improve once an issue has been detected. Please understand that the actions (or inactivity) of one student have an effect on all of the others present in their band.

#### **UNIFORMS**

Performances and concerts, with the exception of a few, will often be conducted in a formal setting. As such, members of the ensemble will be expected to dress according to the appropriate uniform for their ensemble. Each ensembles uniform attire is as follows:

- a. Symphonic Band Black button up dress shirt tucked into black slacks/dress pants with a solid black belt, black dress shoes worn with black socks (that cover the leg when seated).
  - These materials can be purchased at most any store that sells clothes.
- b. Beginning Band WMS Band Polo tucked into black slacks/dress pants with a solid black belt, black dress shoes worn with black socks (that cover the leg when seated).

The band polo will be ordered through the band at the beginning of the school year. materials can be purchased at most any store that sells clothes.

c. Jazz Band\* - WMS Jazz band shirt, and blue jeans.

\*If the jazz band is performing at the same concert/event as the student's primary ensemble, they should wear the uniform associated with their primary ensemble.

Students in all band classes/ensembles will also need to purchase a band t-shirt. These shirts may be different depending on the ensemble the student is in. Information about cost and ordering through the school will be sent home after the beginning of the school year.

There may be an event/function that requires an alternate uniform. If this is the case, prior notice will be given. Usually this only occurs at less formal events and almost always the default attire will be band t-shirt and blue jeans.

We strive to require students to wear professional yet versatile attire that can be use in a plethora of professional or formal settings in order that families don't have to purchase many

new pieces of clothing for multiple organizations. If there is a concern about the cost of the shirt or elements of the uniform, arrangements can often be made, so don't hesitate to contact the director with questions or concerns.

#### **FUNDRAISING**

The Wildcat Band is a nonprofit organization that does not receive any annual funding from the school or district. Still, it is the goal of the organization to create as little financial burden for families as possible, so we require no participation fees and strive to give students access to as many materials as possible. Due to these factors, fundraising is hugely important to us. We rely on fundraising as a primary source of financial provision for the materials and activities necessary for the success of our ensemble. There will be several fundraisers throughout the school year. All band classes will be asked to participate, but families can also choose to make a donation to the Band in lieu of participating. Funds raised and donations received cover purchase of music, instruments, instrument repair, and other miscellaneous materials that contribute to the overall success of the ensemble and our ability to perform. If there are any concerns, please do not hesitate to contact the director.

#### INSTRUMENTS & INSTRUMENT RENTALS

Every student is required to have an instrument and must rent/purchase this instrument by the beginning of the third week of school. If a student is new to the ensemble, mouthpiece testing and instrument placement/choice will occur at the beginning of the year. After instrument placements are finalized, instruments can be rented/purchased. We recommend renting an instrument given that the price to purchase certain instruments can be rather high, but either purchasing or renting is a viable option. If a family already owns an instrument in good repair that a student can/wants to play, then they may use that instrument as well.

Most students, both returning and new, will rent an instrument from a third-party music store. We highly recommend Music Masters and Playground Music given that they're familiar with our ensemble, local, and have many programs to fulfill the needs of our young musicians. Pricing fluctuates depending on the instrument and can be discussed directly with the company. Usually, these rental contracts continue through the summer.

A rental night will be held at the school when parents and students can come and rent instruments from these providers in order that they don't have to go into the stores to talk with

the representatives and get questions answered. This will take place during the first 2 weeks of the year. Dates and times for this event will be given out as soon as possible.

The school does own some instruments that are available for rent during the school year. Some students can/will rent instruments from the school. Sometimes it can be more convenient/affordable for a student/family to pursue rental through the school. When an instrument is rented through Playground or Music Masters, instrument repairs and other services are provided that are not provided with school rentals that ensure the health and longevity of those instruments that cannot be provided for school owned instruments. For all school-owned instrument rentals, a contract will be signed and a fee of \$50 will be assessed for the rental of that instrument. There is a limited availability of school owned instruments.

#### **REQUIRED MATERIALS**

- a. A black 3-ring binder (1"-1.5" should be plenty) is required to keep all music, exercises, warm-ups, and reference sheets that will be provided throughout the year. This will be a separate binder from their other classes and will exclusively be used for band.
- b. A pencil with an eraser is required in all classes and at all events. A pencil pouch for pencils is recommended but not necessarily required.
- c. Certain materials are necessary to play an instrument. It is expected that students have everything they need to play their instrument and maintain the condition of their instrument. These materials will fluctuate depending on the instrument a student plays. Sometimes certain materials are provided with the rental of an instrument through a third party. These materials include but are not limited to instrument cases, mouthpieces, reeds, ligatures, valve oil, cork grease, slide grease, neck straps, swabs, etc.
- d. Students may be required to purchase a method book associated with the instruction provided on their instrument. Information for this book will be provided to each ensemble as the method books may differ from ensemble to ensemble.

#### **TRAVEL**

Occasionally it will be necessary for the band to travel to performance sites, festivals, field trips, etc. The Wakulla County School Board field trip policy requires students to travel to field trip locations on school provided transportation. Students are permitted to travel home from an event with their parent/guardian as long as the director has received a written notice signed by the parent/guardian stating that the transportation arrangements have been approved. In the days leading up to a field trip, students may bring these notes to the director, and they will take them to the administration for approval. These notes need to be received by the director at least 48 hours prior to the start of travel. When traveling with the band, students should remember that they are representing Wakulla Middle School and the entire WMS Band Program. All band rules, school rules, and dress code will be in effect. Always behave in a manner which you would be proud for others to observe. Unacceptable behavior will be dealt with harshly. In addition to the rules set forth by the school and the band handbook (see "CONDUCT") each trip will have specific rules and guidelines. These rules and a complete itinerary will be distributed by the director prior to travel.

#### PRIVATE LESSONS & EXTRA INSTRUCTION

Although a student will learn the fundamental techniques on their instrument throughout their time in band, in class instruction must cover instrumental techniques on all instruments. Students can and should seek private lessons and/or opportunities for instruction on their instrument in order to challenge them and or/help them solidify the techniques they learn in class. These can include having a private lessons teacher/tutor, attending summer music camps, attending instrumental techniques clinics, attending masterclasses, etc. Private lessons allow the student to focus on instrument-specific information and to play music that he or she may not get the opportunity to play during a band class. Playing generally improves tremendously and it is very beneficial to the student. The Director has a list of private instructors in the area for interested parents. Private lessons and extra instruction do not replace the necessity for individual practice.
